- Petition to Reopen a Case
- Petition to Suspend, Modify or Terminate an Order for Withholding

PETITIONS- If filed *later* than 30 days after closing \$ 50.00
Except Child Support or Spousal Support Cases

Examples:

- Petition to Vacate or Modify
- Petition to Enforce, Suspend, or Terminate

PETITION TO REOPEN CLOSED CASES
If filed *later* than 30 days after closing \$ 50.00

PETITION TO VACATE ORDER OF BOND FORFEITURE \$ 40.00

CHANGE OF VENUE (from Jackson County to another County) \$ 30.00

CHANGE OF VENUE (from another County to Jackson County)

Same as filing fee

TRANSCRIPTS- must be obtained from the Court Reporter's Office

MAILING FEES- when the clerk is required to mail, the fee is **\$6.00 + cost of postage** which is determined by the weight of the package and whether the item is to be sent Certified, Return Receipt, Restricted Delivery, etc.

CERTIFIED COPIES- **\$5.00 each plus \$.50 per page copied.**

APPEALS-

Under 100 pages	\$60.00 + cost of shipping
Over 100 pages	\$120.00 + cost of shipping
Over 200 pages	\$120.00 + cost of shipping + \$.25/page copied

REPRODUCTION OF ANY DOCUMENT CONTAINED IN THE COURT FILE-

First page	\$1.00	All additional pages	\$.50

FAX COPIES- Faxes are not acceptable for the Court files, but if you would like copies forwarded to you from our office, the charge is **\$1.00 per page.**

RECORD SEARCH- **\$4.00 for each year searched and for each type of search (Criminal or Civil) plus cost of copies.**

HARD COPY- Copies which are printed output from records maintained on any automated system (computer, microfiche, etc) **\$4.00 per page**

EXPUNGEMENT PETITION-

If there was a case filed in our office following an arrest, then the Expungement Petition will be filed within that case. If an arrest was made, but no case was ever filed in our office, then an MR- Miscellaneous Remedy case will need to be filed and the Expungement Petition will be filed within that case.

Please provide 1 original and 5 copies of the Petition and 6 copies of the Proposed Order along with 2 Self Addressed Stamped Envelopes for the return of your copy of the Petition and Order when completed. The filing fees are as follows:
